Dear Mr. van Elteren, Mr. Vriezen and Mr. Meister,

By letter, dated 23 August 2006, you requested the Netherlands Commission for Environmental Impact Assessment (EIA) to advise on Terms of Reference for an EIA for the complementary dredging of the Amaluza reservoir in Ecuador.

It is my pleasure to submit herewith the Advice on Terms of Reference prepared by a working group of the Commission. I would like to draw your attention to the following:

Hidropaute is probably the most powerful player in the Paute river watershed. For water supply and erosion control, needed for optimizing the energy generation, it depends on the land and water management of the entire basin. Therefore an attitude of 'noblesse oblige' is required towards all efforts related to integrated watershed management. At the moment there are efforts, in particular with financial support of the European Union, to establish a strategy of integrated natural resources management in the Paute watershed, through the CG Paute (Consejo de Gestión de Aguas de la Cuenca del Río Paute). Its functioning seems to leave much to be desired. Hidropaute has been an important financial contributor to this initiative in the past. It is essential that Hidropaute does not limit its involvement in the future only to the areas affected by the environmental management plans of the three (existing and future planned) dams under their supervision, but also actively supports the integrated management of the entire Paute river watershed.

The Commission is willing to perform an independent review of the EIA study once ready, both for (and preferably together with) the authorities in Ecuador (Ministry of Environment and CONELEC) as well as for FMO.
